8. The Shares are held of record by OrbiMed Partners Master Fund Limited ("OPM"). By virtue of such relationships, OrbiMed Capital may be deemed to have voting and investment power over the securities held by OPM and as a result may be deemed to have beneficial ownership over such securities.
